□ deleting my personal data

Note. We may not accept your request to delete your personal information if:

- we have to process personal data:
 - to fulfill legal obligations (tax laws, accounting law, etc.)

 - in the exercise of official authority
- for reasons of public interest in the field of public health
- where processing is necessary for archiving purposes in the public interest, for scientific or historical research purposes or for statistical purposes,
- we have to process personal data to assert or defend against legal claims (eg, if a customer requests the deletion of a particular email communication that the operator wants to use to defend against a legal claim already initiated by that customer or a third party),
- we do not process the personal data to which the request relates,

We process your request free of charge. In the event of a repeated, manifestly unfounded or disproportionate request, we may require a reasonable administrative fee or refuse to act.
